**F101. Permission for the transport of dangerous goods by air****HQ Control: 11/20/04****HQ Revision: 000**

This paragraph certifies the foreign air carrier is permitted to conduct the transport of dangerous goods by air in accordance with relevant requirements of CCAR-276, ICAO Technical Instruction for the Safe Transport of Dangerous Goods by Air (Doc. 9284) and other applicable laws subject to the following conditions:

- a. All dangerous goods are to be carried in aircraft in accordance with the provisions of the CCAR - 276 and ICAO Technical Instruction for the Safe Transport of Dangerous Goods by Air;
- b. The air carrier can carry the following categories of dangerous goods by air
  - Class 2-Gases: Division 2.1, Division 2.2;
  - Class 3-Flammable Liquids;
  - Class 4-Flammable Solids; Substances Liable to Spontaneous Combustion; Substances Which, in Contact with Water, Emit Flammable Gases: Division 4.1;
  - Class 5-Oxidizing Substances and Organic Peroxides: Division 5.1, Division 5.2 (only applicable to COMAT);
  - Class 8-Corrosives;
  - Class 9-Miscellaneous Dangerous Goods
- c. The operator can conduct the transport of dangerous by air at the following airport:

- d. The activities of air transport of dangerous goods conducted by the operator and its ground handling agents are subject to inspection by CAAC inspectors.
- e. Other restrictions and requirements:

- (1) UPS can only conduct the transport of inbound dangerous goods (including Division 2.1, Division 2.2, Class 3, Division 4.1, Division 5.1, Division 5.2, Class 8, Class 9) and the transport of Class 9 at Qingdao Liuting International Airport. The dangerous goods should be kept for less than 12 hours after arriving at Qingdao Liuting International Airport.
  - (2) UPS must ensure all staff (including agents) involved in dangerous goods transport have been sufficiently trained in accordance with the requirements of CCAR-276 and ICAO Technical Instructions.
- f. This permission, unless waived, suspended, or revoked, shall be expired to **Oct. 31<sup>st</sup>, 2010**
