F101. Permission for the transport of dangerous goods by air**HQ Control: 11/20/04****HQ Revision: 000**

This paragraph certifies the foreign air carrier is permitted to conduct the transport of dangerous goods by air in accordance with relevant requirements of CCAR-276, ICAO Technical Instructions for the Safe Transport of Dangerous Goods by Air (Doc. 9284) and other governmental legal and regulations subject to the following conditions:

- a. All dangerous goods are to be carried in aircraft in accordance with the provisions of the CCAR-276 and the current edition of the ICAO Technical Instructions for the Safe Transport of Dangerous Goods by Air (Doc. 9284);
- b. The air carrier may carry the following categories of dangerous goods by air:

Class 1-Explosives;**Class 2-Gases;****Class 3-Flammable Liquids;****Class 4-Flammable Solids; Substances Liable to Spontaneous Combustion; Substances Which, in****Contact with Water, Emit Flammable Gases;****Class 5-Oxidizing Substances and Organic Peroxide;****Class 6-Toxic and Infectious Substances;****Class 7-Radioactive Material;****Class 8-Corrosives;****Class 9-Miscellaneous Dangerous Goods.**

- c. The foreign air carrier may conduct the transport of dangerous goods by air at the following airports:
