## 危险品航空运输许可

### PERMISSION FOR TRANSPORT OF DANGEROUS GOODS BY AIR

编号/NO. SQ - ZN - 20100629

批准 新加坡航空公司 按照《中国民用航空危险品运输管理规定》(CCAR-276)、国家其他法律法规和批准的危险品训练大纲的程序实施危险品航空运输,但应当符合下列要求:

This permission authorizes Singapore Airlines Co. Ltd to conduct the transport of dangerous goods by air in accordance with relevant requirements of CCAR-276, China's laws and regulations and CAAC approved training program for the Safe Transport of Dangerous Goods by Air, subject to the following conditions:

一、允许运输下列《危险品航空运输技术细则》规定种类的危险品:

The following categories of dangerous goods described by "Technical Instructions For The Transport Of Dangerous Goods By Air" can be transported:

- 爆炸品 (Explosives)
- 气体 (Gases)
- 易燃液体 (Flammable Liquids)
- 易燃固体; 易于自然的物质; 遇水放出易燃气体的物质 (Flammable Solids; Substances Liable to Spontaneous Combustion; Substances which, in Contact with Water, Emit Flammable Gases)
- 氧化性物质; 有机过氧化物 (Oxidizing Substances and Organic Peroxides)
- 毒性和感染性物质 (Toxic and Infectious Substances)
- 放射性物质 (Radioactive Material)
- 腐蚀性物质 (Corrosives)
- 杂项危险物品 (Miscellaneous Dangerous Goods)
